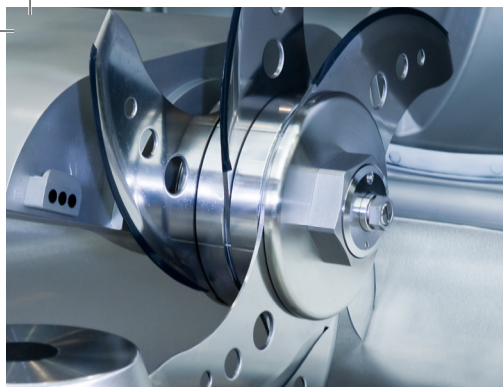

In addition to the food and beverage industries, ISO 21469 also applies to lubricants used in pharmaceutical, cosmetics and animal feed manufacturing. Being certified enables you to do business in markets other than food and beverages.

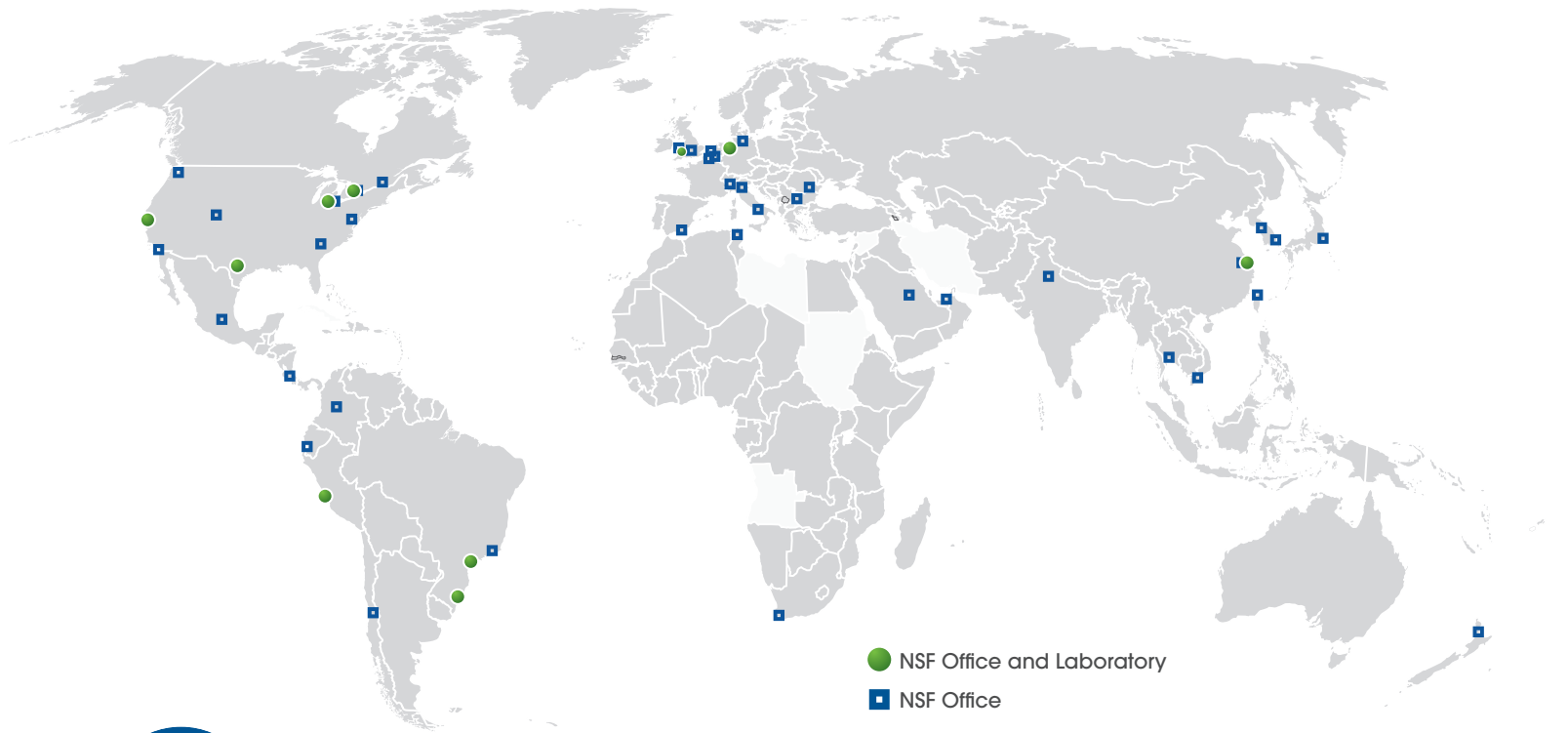
